Qikiqtaaluk Corporation Embarks on a New Era with the Saputi II Factory Freezer Trawler

Qikiqtaaluk Corporation (QC) is proud to announce a significant milestone in its commitment to sustainable fishing and economic development in the North. On September 26, QC concluded the signing of an agreement with Freier Shipyard in Vigo, Spain, for the construction of its cutting-edge Factory Freezer Trawler, the Saputi II. This remarkable vessel, designed by Skipsteknisk, and supported by Allswater Marine Consultants, marks a new chapter in our mission to provide the highest quality seafood products while fostering prosperity within our communities.

Setting Sail with Saputi II: A Glimpse of the Future

The Saputi II will be a vessel of exceptional capabilities and efficiency, measuring 79 meters in length and 17 meters wide. Designed as a multi species, factory freezer vessel, it will play a pivotal role in harvesting shrimp and Greenland halibut sustainably. At the heart of this endeavor is our commitment to environmental stewardship and responsible fisheries management. With a chosen engine that sets a new standard for efficiency in its class, we aim to not only provide top-quality seafood to the world but also to protect the pristine Arctic environment we call home.

Comparing the capacities of the Saputi and Saputi II, the Saputi II will handle 750T (versus 580T) of shrimp and around 1,100T (versus 900T) of turbot, representing a significant increase in our capacity to provide the highest quality seafood products to the world, while increasing our operational efficiencies. Having the latest in technology for fishing, processing and crew comfort, the vessel will employ 28 to 30 personnel per trip. QC looks forward to training and mentoring even more Inuit to work on this new vessel.

The Saputi II Factory Freezer Trawler stands as a symbol of progress, sustainability, and community empowerment. QC looks forward to the vessel's completion and its vital role in creating prosperous and sustainable fisheries for the North.
